C. Gussen made a motion to discuss Resolution K - Authorize Submission of Referendum - Municipal Open Space, Recreation, and Farmland and Historic Preservation Trust Fund - November 2008. Seconded by Mayor Katz.

C. Gussen would like to send the proposed Resolution for review to the stake holder advisory boards. C. Gussen stands by his vote to spend the MOST dollars, but he thinks there is enough concern and reason on the wording to reshape it. C. Gussen inquired about the time frame that the Council has to pass the Resolution with adjusted wording.

Mr. Turitz informed C. Gussen there is enough time to wait for a response from the various boards because the Referendum question needs to be submitted to the County by August 1, 2008.

C. Gussen would like to send out to the corresponding boards for feedback. He would like to know, meeting wise, if there is enough time to do so.

Mrs. Fall explained that the first meeting in July is on the 8th and it is a Workshop Meeting and the second meeting on the 22nd is the Regular Meeting. Mrs. Fall will contact the PPRAB, Environmental Commission, MOST Advisory Board and Historic Preservation Commission and ask for a response by July 1st so it can be placed on the Workshop Meeting for discussion. Mr. Gussen asked if the resolution could be more restrictive with respect to how the funds are spend, what percentages for specific types of projects.

C. Gussen made a motion to table Resolution K and to send the Resolution draft to particular boards for discussion. Seconded by DM. Parker and carried by the following vote:

In Favor: C. Feit, C. Kates, DM. Parker, C. Honis, C. Gussen, Mayor Katz.

Opposed: None.

Absent: C. Rudolph.

C. Kates had a concern about two of the Resolutions, 160-08 and 161-08, that were passed at the last meeting and considered changing her vote. She is leery about leasing through the Bergen Bank and legal issues with the BCIA. C. Kates is concerned about the Township's involvement. C. Kates wishes the minutes of that meeting to reflect her comments.

Mr. Turitz informed C. Kates that these minutes can reflect her concern but the last meeting's minutes will not due to the fact that she said it today.

Mr. Turitz wanted to explain to C. Gussen that the wording on page 2 of the MOST Referendum Resolution cannot be changed pursuant to state law, some of the whereas statements can be changed.

C. Gussen wants to be able to earmark a portion of the money for particular purpose, i.e. land acquisition. C. Gussen asked if they had the authority to do so.

Mr. Turitz explained that Council does have the authority when they decide how to spend the money, but not in the Resolution authorizing the MOST tax. C. Gussen inquired about not being able to restrict themselves ahead of the game. Mr. Turitz will give it some thought and provide a further report.

Mrs. Fall clarified which specific boards Council wishes to have review and give feedback. C. Gussen wants to achieve having a better chance of passing by tweaking the wording. The Boards that will review will be: PPRAB, EC, MOST, HPC. Council concurred.

Honis made a motion that the reading of the bill list be dispensed with inasmuch as it has been posted on the bulletin board all day and that it be authorized paid in the amount of \$ 3,575,879.00 when properly approved, sworn to and the money is available. Seconded by DM. Parker and carried by the following vote:

### **GOOD AND WELFARE**

Asher Goldstein - 126 West Laurel Parkway - Spoke about Teaneck Clean and Green. Thanked Council for allowing the businesses that are not associated with certain groups within the Township to participate in the weekend. Feels a traffic study needs to be done on Windsor Road North, near State Street, putting dotted lines in and having drivers commit to which direction they are going can alleviate the traffic back up on State Street. The Plaza and Queen Anne Road can be confusing for both pedestrians and drivers, a traffic circle is a successful way to improve this area.

Kena Hiller - 366 W. Englewood Avenue - Asked about a plan for commuter parking.

Ronald Mays - 26 W. Englewood Avenue - Spoke about Unity Day and Teaneck coming together as one.

Steven Kaye - 95 Bennett Road - Spoke about his appreciation for Renee Karibi-Whyte and would like Council to do everything they can to assist PSE&G to make the needed repairs after last night's storm..

Frank Ramos - 1035 Eastlawn Drive - Thanked Council for what they do for the kids.

Ari Jacobson - 320 Churchill Road - Spoke about Clean and Green weekend and his sons wanting to go back again. Is distressed by previous comments made in regards to who has suffered more during the election.

Ken Egbert - PBA President - Talked about the Teaneck Police Department command structure with the impending retirements. Feels this issue should be addressed immediately and proactively.

Joan Davis - 976 Alpine Drive - Spoke about how there were important issues brought up tonight. Ms. Davis is concerned about the environment and is shocked by all the damages of trees. The Township should redirect its efforts from businesses to the environment; do things as a community to cut gas consumption.

Barbara Ley Toffler - Thanked residents that voted for her, wants "Team Teaneck" to apologize for their mailing, after "Team Teaneck" apologizes she wants C. Honis to address her comments made, and supports new leadership.

James Kinlock - 73 Shepard Avenue - Shepard Avenue is going to be paved and Mr. Kinlock would like to know where the residents will be able to park for those two days and if the town will be paying for the curbs and sidewalks.

Tasha Morton - Sherwood Avenue - Spoke about Council Elect Barbara Ley Toffler's comments about what she will do and also spoke about leadership.

Carter Jackson - 122 Hurliman Road - Asked Council for somebody to take time for the community to come together. Council needs to take leadership.

Ray Moore - 173 Bogert Street - Said that we all come here from different parts of the world. Spoke about integrity and Council being watched.

Laura Zucker - 62 Hillside Avenue - Spoke about racist literature and the election.

Joseph Bodner - 1410 Somerset Gate - Hurt by comments made by C. Honis. Even though they may not have been intentional she can apologize to the people it offended.

Howard Rose - 575 Northumberland Avenue - Stated that the u-turn sign in front of the post office is blocked by trees and wishes that Council would set up a Good and Welfare day where there could be a dialogue.

Henry Pruitt - 113 Vorhees Street - Stated that something is dividing the Jewish community and the black community. Someone around town is trying to destroy the unity.

Miriam Warberg - Briarcliffe Road - Is saddened by what is going on in the community; children deserve a peaceful environment.

Michael Puryear - 1698 Teaneck Road - Feels the things that are wrong came to the surface during the Municipal Election. Councilmembers should be leaders.

C. Kates made a motion to extend Good and Welfare an extra fifteen minutes. Seconded by DM. Parker and carried by the following vote:

In Favor: C. Feit, C. Kates, DM. Parker, C. Honis, C. Gussen, Mayor Katz.

Opposed: None.

Absent: C. Rudolph.

Mr. Navder - Carlton Terrace - Spoke about the relationship between the blacks and the Jews and that it would be appropriate for C. Honis to offer an apology.

Alan Sohn - 752 Cottage Place - Spoke about working together to solve problem, the budget, economic and community relation issues, and the new Council in three weeks.

Naomi Cramer - 623 Maitland Avenue - Commented on the Teaneck Police Department contracts and the contractors guaranteeing their work. Thanked Renee Karibi-Whyte for all the work that she had done on the Planning Board.

Clara Williams - 21 Stuyvesant Road - Recently went to her high school reunion for Teaneck High School; the Teaneck High School alumni spoke about various aspects of Teaneck they felt they received during high school including, diversity, multiculturalism, and a multiethnic community. Ms. Williams feels the Township is regressing.

Comments included; a read letter to council from the poll workers, thanks to the Mayor for his letter to Ms. DeBari that was also submitted to the Suburbanite, statements of due process, issues with the challengers, demands of Council to reinstate, certain parties being involved in a nonpartisan election, and the reading of the names and addresses of the challengers during the election.

C. Feit made a motion to close the Good and Welfare portion of the meeting to the public. Seconded by C. Kates and carried by the following vote:

In Favor: C. Feit, C. Kates, DM. Parker, C. Honis, C. Gussen, Mayor Katz.

Opposed: None.

Absent: C. Rudolph.

Mrs. Fall advised Dr. Goldstein that she will review his traffic concerns with staff, Mrs. Hiller that the Township has designated certain lots for commuter parking for residents only, Mr. Kinlock that the driveway apron and curb work is done with the road resurfacing to make sure the apron meets the road and that the residents will be inconvenienced for two days and recommends parking on neighboring streets. Mrs. Fall asked Mr. Rose which Post Office he was referring to and she will address the sign appropriately. Mrs. Fall explained to Ms. Cramer that it is required for the bidder to provide a performance bond and maintenance bond.

Mrs. Fall responded to Mr. Egbert saying that she was dismayed and disappointed by his comments. For the past two years she has had monthly meetings with the PBA/ SOA to address any comments and concerns that they may have had and these questions that he has brought forward today were not raised at the last meeting, a little over 2 weeks ago. He could have contacted her at any time. Mrs. Fall explained that there is a transition plan in place with the appropriate command staff.

C. Feit feels that sometimes we do need to hit bottom in order to rise up. He feels that Council differences on issues are very very minor. The new Council may be the opportunity the Township needs to change things around. We have had two contentious elections in a row. C. Feit feels that enough is enough and we need to move forward.

C. Kates agreed with C. Feit. C. Kates does not think it is coincidental of the challengers to be representatives of a certain group. Hopes Teaneck remembers that it is a nonpartisan professionally managed community. C. Kates spoke about the County politics influencing Teaneck, the shared vision of African Americans and Jewish people in the fight for civil rights and that she feels the community does not trust the Council. Recommends the Advisory Board on Community Relations needs to be more involved and Council needs to use them.

DM. Parker feels there is a "cloud" over Teaneck and starting with the new Council she hopes the "cloud" to move. DM. Parker spoke about the election and the challenger "super pass". DM. Parker is upset by the two poll workers getting fired by the County. DM. Parker asked her colleagues to pass a Resolution supporting poll workers to have their due process. DM. Parker spoke about the new Council being organized, "Leadership starts with us." She read aloud the resolution that she wrote.

DM. Parker made a motion to approve a resolution 236-08. Request Bergen County Board of Election Hold Hearing for Poll Workers. C. Gussen seconded.

Mayor Katz explained that he not normally been in favor of passing these types of resolutions to support. He likes to keep his focus on the day-to-day of Teaneck, but he will be supporting this resolution.

Carried by the following vote:

In Favor: C. Feit, C. Kates, DM. Parker, C. Honis, C. Gussen, Mayor Katz.

Opposed: None.

Absent: C. Rudolph.

DM. Parker will write a letter as an individual supporting the reinstatement of the poll workers but does not believe that it is in Council's purview to tell the County to reinstate them.

C. Honis spoke about the last forum before the election and that the diversity in Teaneck is the greatest asset. C. Honis explained that she has received numerous letters from residents, C. Honis read a few of the lines out loud. She stated that everyone in the room, at the forum, knew what she was referring to when she said her statement about the death penalty. It was not her intent to harm anyone with words. She spoke about insensitive words and that her accusers are being insensitive as well. C. Honis was highlighting the death penalty in this country. She would like her accusers to join in and asking the Federal Government in abolishing this form of death penalty.

C. Gussen commented that he was stunned that C. Honis believes no one in that room was offended, he was there and he was offended and her running mate, Council Elect Toffler said that she cringed when that came out of her mouth.

Mayor Katz read aloud the letter he wrote to Eileen DeBari regarding the firing of the poll workers. Mayor Katz feels we need to work together on healing and work together as a community.

Mayor Katz reminded residents to sign up for the alerts on our new website.


