This map was created, in part, utilizing parcel, municipal boundary and location data provided by the New Jersey Geographic Information Network.

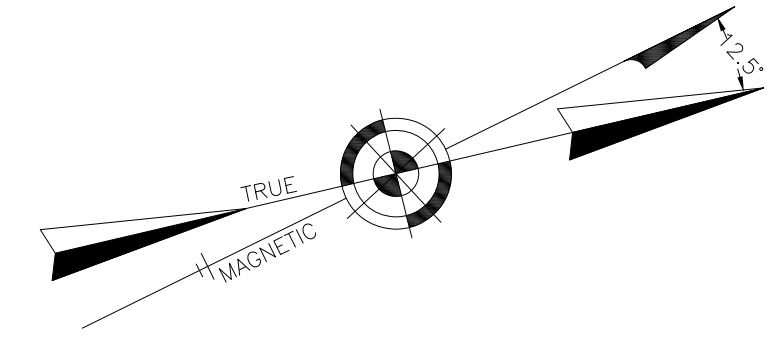

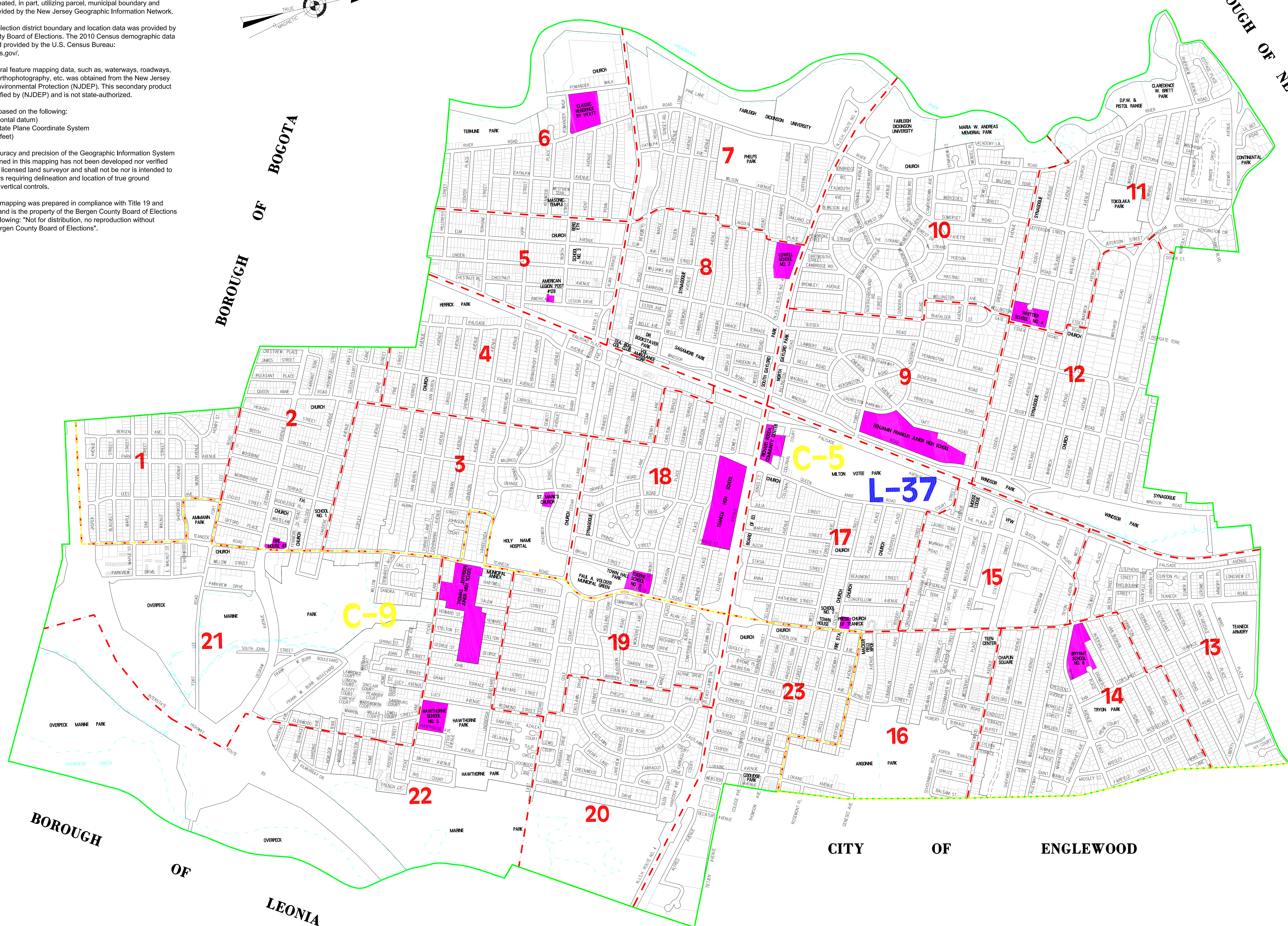
